WHILE THERE IS NO FIXED MONETARY LIMIT ON THE CREDIT THAT WILL BE EXTENDED UNDER THIS AGREEMENT, THE CUSTOMER IS EXPECTED TO USE SUCH CREDIT ONLY FOR HIS/HER REASONABLE REQUIREMENTS.

CUSTOMER WILL NOTIFY PARK FUELS IN ADVANCE SHOULD CUSTOMER VACATE THE PREMISES.

PAYMENT IS DUE 30 DAYS FROM THE DATE OF THE DELIVERY. SERVICE CHARGES ARE APPLICABLE TO ACCOUNTS NOT PAID WITHIN THE 30 DAY TERMS AND ARE ASSESSED AT 2% PER MONTH (26.82% PER ANNUM) ON THE TOTAL BALANCE 30 DAYS OR MORE PAST DUE. Initial: _____
